

## Instructions for E.A.G.L.E. Registration

E.A.G.L.E. membership allows you and your children to participate in all EAGLE activities.

Early Bird membership fee for the 2023-24 school year is \$75 per family. This fee pays for E.A.G.L.E. membership through June 30, 2024. The window to join at this rate is July 1 - August 3, 2023. After August 3rd, the membership fee for the 2023-24 school year (ending June 30, 2024) will be \$100. Your E.A.G.L.E. membership application is not complete until you have filled out the application on the E.A.G.L.E. website and payment and all hard copies of the below documents are turned in so make sure all of that is taken care of before the deadline. See membership page on the E.A.G.L.E. website for dates/times/location to turn in hard copies of membership forms and payment.

August 3rd is also the deadline to join E.A.G.L.E. to be able to participate in the fall semester of enrichment classes. (Please note that E.A.G.L.E. membership does not guarantee a spot in enrichment classes.) If joining after August 3, 2023, you will not be able to participate in the fall semester of enrichment classes, but you may participate in other E.A.G.L.E. activities including the spring semester of classes as space allows. For those joining later, there will be a deadline to join to be able to take Spring Enrichment classes. See membership page on the E.A.G.L.E. website for the deadline date to join to be able to participate in Spring Enrichment classes as well as the dates/times/location to turn in hard copies of membership forms and payment.

By signing below, I commit to standing in agreement with the given Statement of Faith, Behavior & Dress Standards, and Code of Conduct and will continue to do my best in following these standards with my life. I understand that I am enrolling my child(ren) in a non-denominational group of Christian families, and that my children will be taught using Christian principles and standards of living. I will willingly assist my children to follow E.A.G.L.E.'s standards while they are in attendance at all E.A.G.L.E. functions even if they are not my personal standards. I understand that while denominational differences are not purposefully discussed in the classroom, I will instruct my children that they will bring Spiritual Belief questions to their parents out of respect for the teacher and their classroom. Teachers and assistants in the classroom will divert such topics to parents for final answers. I understand that E.A.G.L.E. is a private organization and if I do not align with the Statement of Faith, Behavior & Dress Standards, and Code of Conduct my membership may be put on hold or may be denied. My life, belief, and conduct outside of E.A.G.L.E. will reflect E.A.G.L.E.'s Statement of Faith and Code of Conduct. If at any time it is seen in conflict with these rules, I will be brought before the E.A.G.L.E. leadership board with the possibility of expulsion. Violations will be addressed with both student and parent, with parents being held ultimately responsible for resolution. If resolution is not achieved, the E.A.G.L.E. Board reserves the right to limit or revoke membership without reimbursement.

## E.A.G.L.E. Code of Conduct

This Code of Conduct is for serving at E.A.G.L.E. in any capacity. In addition to being a homeschool support group, E.A.G.L.E. is also a co-op and for the co-op to operate effectively, all families are required to volunteer in some capacity. Each family must agree that they both believe and live by the following code of conduct. We appreciate your willingness to serve at E.A.G.L.E. and be a part of the co-op.

1. I agree and live by a traditional definition of marriage, as described in Scripture. God's gift of marriage, which the Creator defines as the union of one (biological) man and one (biological) woman (Genesis 2:18-25).
2. I also agree that I do not use illegal drugs or practice illegal activities.
3. I agree to pass a criminal background check.
4. I believe in and agree to comply with the E.A.G.L.E. Statement of Faith, Behavior & Dress Standards, and Code of Conduct.

By signing the statement on the "Agreement to E.A.G.L.E. Statement of Faith, Behavior & Dress Standards, and Code of Conduct" form, I have read and understand the E.A.G.L.E. Code of Conduct for Service. I am willing to serve under the conditions listed above.



## E.A.G.L.E. Homeschool Behavior and Dress Standards

(Updated June 3, 2023)

Eagle leadership has developed these standards as guidelines for all Eagle members (students and parents) to follow during Eagle activities and events. These rules are not all-inclusive; it is virtually impossible to address every detail and aspect thereof since there are many different convictions concerning these topics. In instances where rules do not expressly state a given situation, "appropriate" dress will be at the discretion of the event organizer or the Eagle Board as necessary.

Anyone whose attire or behavior is detrimental to the Christian environment that Eagle is committed to maintaining will be asked to leave the event until attire or behavior is corrected. Any fees paid for the event will be forfeited.

1. As a matter of personal pride, Eagle members should maintain high standards of neatness and appropriateness of dress, appearance, and behavior. Dress and conduct yourselves in a way that reflects Christ and honors Him.
2. Shorts should not exceed 6 inches above the top of the knee and must not expose any undergarment. This 6-inch rule also applies to rips or cutouts in pants, etc.
3. Tight/form fitting clothing (bicycle shorts, spandex, leggings, etc.) is inappropriate unless worn underneath a garment covering your bottom fully.
4. Dresses and skirts should be appropriate for bending, stooping, sitting, and working overhead and should also not exceed 6 inches above the top of the knee, including slits.
5. Shirts should not show midriff while walking, standing, or sitting. No blouse should be so low in the front or sides to expose any part of the breast or so low in the back to expose the shoulder blades. No muscle shirts, spaghetti straps, racer backs, or strapless tops. Basketball jerseys or other such transparent or sheer clothing need appropriate undergarments.
6. Shoes are required. Do not wear cleats indoors.
7. Clothing or jewelry/ornamentation that contains or depicts illegal drugs, alcohol, tobacco, profanity, violence, suggestive language, derogatory symbols, or negative ethnic remarks is inappropriate.
8. Public displays of affection are not allowed at Eagle functions.
9. No skateboards, roller blades, Heelys, bikes, etc., are allowed on campus.
10. Use of, possession of, or transfer of tobacco products or e-cigarettes will not be permitted at Eagle functions.
11. Students are not allowed to have firearms or weapons of any kind at Eagle functions.

WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to participate in Eagle Homeschool Inc. during the 20\_\_\_\_ - 20\_\_\_\_ school year. I hereby release, waive, discharge, and covenant not to sue Eagle Home School Inc. (hereinafter referred to as "EAGLE"), its officers, servants, agents, or any location that is used by EAGLE, and employees (hereinafter referred to as "releasees") from any liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained be me, or to any property belonging to me, whether caused by the negligence of releasees, or otherwise, while participating in EAGLE activities, or while in, on or upon a facility or premise used by, or in any place or places connected with, EAGLE.

2. I am fully aware of risks and hazards connected with activities while participating in EAGLE and am fully aware that there may be risks and hazards unknown to me connected with being at a facility or on the premise while participating in EAGLE activities. I hereby elect to voluntarily participate in EAGLE, to enter upon the premises used by EAGLE and engage in the activities, knowing that the conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in EAGLE, whether caused by the negligence of releasees or otherwise.

3. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs they may incur due to my participation in EAGLE, whether caused by the negligence of any or all of the releasees, or otherwise.

4. It is my express intent that this release shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge, and covenant not to sue the above named releasees.

In signing this release, I acknowledge and represent that:

A. I have read the foregoing release, understand it, and sign it voluntarily as my own free act and deed;

B. No oral representation, statements or inducements, apart from the foregoing written agreement, have been made;

C. I am at least eighteen (18) years of age and fully competent; and

D. I execute this release for full, adequate and complete consideration fully intending to be bound by same.

# EAGLE Homeschool Association Statement of Faith

8.18.2022 revision

## Our association and leaders are guided by these principles:

- The Bible is the inspired and infallible word of God. It is never wrong and never contradicts. (2 Tim 3:16; 2 Peter 1:20-21; Psalm 119:60)
- God has existed for all eternity in three persons: God the Father, God the Son, and God the Holy Spirit. (2 Cor 13:14; 1 John 5:7; Gen 1:26, 3:22)
- Jesus Christ, born of a virgin, is God and came in human flesh being fully God and fully man and is/was without sin. (Matt 1:23; John 1:14; 1 Tim 3:16)
- Man, by nature, is sinful and inherently in need of salvation. (Rom 3:23; 6:23)
- Christ's death provides atonement for our sins. He rose from the dead in the flesh. (Rom 5:9-11; 1 Cor 15:1-8; John 20:27)
- Salvation is offered as a free gift to all sinners. This gift must be responded to by individual faith, not trusting in any personal works, but only in the death and resurrection of Christ alone. (Rom 4:5, 5:15-18; Eph 2:8-9)
- Jesus will literally come to earth again in the Second Advent. (1 Thes 4:14-18; Rev 1:7; Matt 24:30)
- We believe the Bible's literal account in Genesis of the creation of the world and all that exists is the only framework for teaching in all science, origin of life and history courses. (Gen 1; Ex 20:11, 31:17; Mark 10:6)
- We believe that all human life is precious in the sight of The Lord and the word of God teaches us to protect those lives from the time of Conception (or from the womb). (Isa 44:24, 49:5; Jer. 1:5, Luke 1:41, Gal 1:15)
- Children are a heritage from the Lord, entrusted to parents to train up in righteousness for His glory. (Eph 6:4; Titus 2:4; Col 3:21)
- The Bible describes human gender in binary terms. Gender and biological sex are equivalent and cannot be separated. We believe that God disapproves of and forbids any attempt to alter one's gender by surgery or appearance; that the only Scriptural marriage is the joining of one man and one woman. (Gen 1:27, 2:24; Matt 19:4; Rom 1: 26-29; Heb 13:4)
- We believe that the term 'marriage' has only one meaning and that is marriage sanctioned by God which joins one man and one woman in a single, exclusive union, as delineated in Scripture. (Matt 19:4-6; 1 Cor 7:2; Gen 2:24)
